Ellucian Step Challenge

A total of eighteen (18) prizes will be awarded

1. Eligibility

Only current customers and prospects (“prospects” means those institutions currently in any stage of an Ellucian sales cycle) of Ellucian Company L.P. (“Ellucian” or the “Company”) are eligible to participate in the Ellucian Step Challenge (the “Challenge” or the “Contest”). In-person Ellucian Live 2023 attendees are eligible.

2. How to Enter:

Download the Heka Well mobile app and synch it to your step tracker (e.g., Fitbit, Apple Watch) and track your steps from 12:01 AM CST on Monday, March 27th through 11:59 PM CST on Wednesday, March 29th.

You may download the Heka Well mobile app from Google Play or App Store. You will need to set up your Challenge account by launching the app and choosing the “Ellucian 2023 Step Challenge.” Complete the registration process and pair it with your tracker. Heka Well app pairs with Apple Health and Google Fit and will also import step data from Fitbit, Garmin, and Apple Watch. Then start stepping!

Steps may be accumulated both by walking and scanning in for bonus steps. (As further described herein).

Step Levels:

All participants who reach the following Step Levels will be entered into a prize drawing. You will be entered into the prize drawing based on the highest Step Level you reach (see below), and all winners will be chosen at random. There will be six (6) random winners selected at each of the following levels:

- Level 1: 25K (~10K daily with steps and scan-in bonus) 6 Random Winners
- Level 2: 35K (~15K daily with steps and scan-in bonus) 6 Random Winners

- Level 3: 45K (~18K daily with steps and scan-in bonus) 6 Random Winners

Each prize has an estimated value of \$150 - \$450. Each winner will be contacted after the conference and asked for their preferred delivery address. All winners are responsible for applicable state and local taxes. All prizes are provided by Ellucian “as is” and without a warranty of any kind.

BONUS ACTIVITY

To support your Challenge goals, scan QR codes at various locations to obtain step bonuses. Once the Challenge has begun, press the “Bonus Activities” **selector in the Heka Well app and choose “Scan-In” using the in-app viewer, scan-in QRs at the following locations:

- 1. Podcast:** Bonus to be granted once for a boost of 1,500 steps.
- 2. Swipe Out Hunger:** Visit the booth to be able to scan a bonus activity QR Code. Bonus to be granted once for a boost of 3,500 steps.
- 3. Swag Store:** Take a picture at the store. Bonus to be granted once for a boost of 1,500 steps.
- 4. Ellucian Booth** – Visit the booth to be able to scan a bonus activity QR Code. Bonus to be granted once for a boost of 3,500 steps.
- 3. Odds of Winning:** The odds of winning the Challenge will depend on the number of entrants participating. All decisions regarding the Challenge will be based on Ellucian’s sole and independent judgment.
- 4. Selection of Winner:** One prize will be provided to each of the three (6) winners selected randomly from each of the three (3) Step Levels. The drawings will take place the week of April 2nd.
- 5.
